Please join us for the **Raleigh Spring Dressage** show on **April 11-12, 2020** at the *West Complex* onof the Hunt Horse Complex on the North Carolina State Fairgrounds in Raleigh.

Note that this is an OUTDOOR competition using the rings west of Barn E on the facility. The main coliseum and other rings at the Hunt Horse Complex will be used by another competition. Only mobile vendors, including vendor supplied trailers or tents, can be accommodated at this event.

Several of our sponsors have exclusive vendor rights at this and other Rosinburg Events competitions. We cannot accept any tack/riding apparel shops, or insurance companies as vendors. In addition, the facility may limit and must pre-approve all food or beverage vendors. However, businesses that sell equestrian gifts and other specialties or services are welcome to attend.

Vendors must furnish Rosinburg Events, LLC with a Certificate of Insurance as evidence that Worker's Compensation Insurance (if applicable) and Public Liability Insurance is in force during the show. In addition, a photocopy of your North Carolina State Certificate of Registration, which serves as evidence that you have met the sales and use tax registration requirements for that jurisdiction and that you are authorized to collect and remit tax as required by law.

When your contract is returned, **with full payment**, you will receive confirmation for your vendor space. Trade Fair spaces will NOT be reserved until the contract and fees are received by the show.
